The Center for Advanced Study in the Behavioral Sciences (CASBS) will select approximately 20 residential fellows for the 2009-2010 academic year from the applicant pool. Group projects may apply for the 2009-2010 academic year or for one or two years later, depending on the project timeline. Fellows will be assisted in relocating as needed in order to be in residence for the tenure of the fellowship, typically 9 to 11 months beginning in early September. The Center's trustees are committed to the concept of a residential fellowship and consequently Fellows must reside during their fellowship term in a community within ten miles of the Center; San Francisco, Berkeley, the East Bay, and San Jose, for example, do not fulfill this requirement. Center staff provides assistance in finding housing and schools for those relocating for the fellowship year.

ELIGIBILITY: Applicants with a Ph.D., professional degree (e.g., J.D., M.D.) or equivalent foreign degree are eligible to apply. The Center will also consider applicants who have achieved an equivalent level of professional reputation. Faculty at all academic levels or independent scholars may apply, provided they exhibit a high level of achievement (adjusted for rank) including a strong record of research publications. Applications are encouraged from younger scholars at least 3 to 4 years past the doctorate, typically for a fellowship year soon after achieving tenure. (This is not a 'post-doc' program for newly-minted Ph.Ds.) The Center encourages applications from ethnic minorities, women,

international scholars, and scholars from less research-oriented colleges and universities. Small multidisciplinary groups of qualified scholars may choose to apply together for a collaborative group project on a particular topic.

FUNDING: A significant portion of the total stipend is generally provided by the individual Fellow from sabbatical funds and external funding from awards and grants. Depending on available funds and the needs of class members, the Center attempts to provide the remaining stipend according to the following principles. A Center stipend is based on the Fellow's salary for the year before residence. That stipend shall not exceed one-half of the Fellow's academic year (nine-month) base salary for that year and is additionally subject to an upper limit set by the board of trustees. The Henry Dreyfus Teacher-Scholar Awards Program supports the research and teaching careers of talented young faculty in the chemical sciences. Based on institutional nominations, the program provides discretionary funding to faculty at an early stage in their careers. The Henry Dreyfus Teacher-Scholar Awards Program is based on accomplishment in scholarly research with undergraduates, as well as a compelling commitment to teaching.

ELIGIBILITY: The Henry Dreyfus Teacher-Scholar Awards Program is open to academic institutions in the States, Districts, and Territories of the United States of America that grant a bachelor's or master's degree in the chemical sciences, including biochemistry, materials chemistry, and chemical engineering. If the department has a modest Ph.D. program, the nominee's research accomplishments must be almost exclusively with undergraduates. Nominees must hold a full-time tenure-track academic appointment, be between the fourth and twelfth years of their independent academic careers, and be engaged in research and teaching primarily with undergraduates. But growing interdependence has made one thing clear: In the 21st century, the security and well-being of all of Earth's peoples is increasingly connected to that of others. Strife and unrest in faraway places can create ripples that spread around the globe. Freer, faster movement across borders makes it harder to curb flows of dangerous weapons and deadly materials; contain infectious disease, pollution, and financial disruption; distinguish terrorists from tourists and traders; and regulate the spread of technologies with the potential to change the course of human history or alter Earth's ecology. Progress in coping with such complex and interconnected challenges will require ingenuity, resolve, and cooperative action on many fronts. Many factors will influence the world's chances of success. The RBF's Peace and Security Program focuses on two factors that may be key to advancing or undermining global problem solving: (1) the content and style of U.S. global engagement in the face of new perils and opportunities; and (2) the strength and quality of relationships between Muslim and Western societies. In addition, peace and security is a theme that may be identified for attention in one or more of the Fund's pivotal places. For democracy to flourish and deliver on its promises-including political participation, human rights, access to justice, a good education, an improved quality of life, a healthy environment, and personal security-its citizens must be engaged, empowered, and assertive. Similarly, institutions of governance must be inclusive, transparent, and responsive. Over the past two decades, there has been a dramatic increase in the number of countries on the democratic path or with democratic systems of government in place. The frequent failure, however, of both new and established democracies to deliver on democracy's promises undermines the commitment to democratic practices. In addition, the progress of globalization increases the significance of decisions made by transnational institutions such as multilateral organizations, multinational corporations, international financial institutions, and global civil society groups. Yet these decisions are often made with inadequate inclusiveness, accountability, and transparency and may in fact preempt or distort legitimate national and local decision-making processes. The Fund's Democratic Practice program has two parts: the health of democracy in the United States and the strength of democracy in global governance.

Research in the collections of the Vatican Film Library by qualified scholars is supported by two fellowship programs. The Vatican Film Library Mellon Fellowship is offered through the Vatican Film Library for research of periods between two and eight weeks in length. The NEH Research Fellowship is offered through the Center for Medieval and Renaissance Studies at Saint Louis University for scholars resident during the fall or spring terms. This fellowship encompasses research conducted in both the Vatican Film Library and in the rare book and manuscript collections of Pius XII Memorial Library. These fellowships cannot be held concurrently.

CONFERENCES are defined as public events that are comprised primarily of oral and poster presentations to a larger audience of anthropologists. Priority is given to major conferences sponsored by large international anthropological organizations (e.g., the European Association of

Social Anthropologists, European Anthropological Association, Pan African Anthropological Association, and Latin American Anthropological Association) that serve as their annual or periodic meetings. The majority of the funds granted to such conferences is expected to be used towards expenses for international scholars who are making presentations at the conference and would not otherwise be able to attend. WORKSHOPS are defined as working meetings that focus on developing and debating topical issues in theoretical anthropology. Workshops involve a small group of scholars who meet for a sufficient period of time to deal intensively with the topic. Priority is given to those workshops that devote the majority of time to discussion and debate rather than to the presentation of papers. It is expected that workshops will result in a publication.

The International Collaborative Research Grant (ICRG) supports international research collaborations between two or more qualified scholars, where the principal investigators bring different and complementary perspectives, knowledge, and/or skills to the project. Supplemental funds are also available to provide essential training for academic research participants in ICRG-funded projects (co-applicants, students, as well as other professional colleagues). By encouraging international collaborations, the grant contributes to the development of an international anthropology that values and incorporates different national perspectives and resources. By providing training funds, the grant helps to build capacity in countries were anthropology may be under-resourced.

ELIGIBILITY: Principal Investigators must hold a doctorate or equivalent in anthropology or a related discipline.

FUNDING: The grants are for a maximum of \$30,000 for the research project. Proposals which include the optional training element can have an increased funding request up to a maximum of \$35,000, of which no more than \$10,000 can be for essential training purposes. Under special circumstances grants can be renewed to support longer-term research projects.
